Knights Facts and Figures

The Knights of Columbus is the world's largest Catholic fraternal service organization. Founded in the United States in 1882, it is named in honor of Christopher Columbus.

There are more than 1.7 million members in 14,000 councils, with nearly 200 councils on college campuses. Membership is limited to "practical Catholic" men aged 18 or older.

Councils have been chartered in the United States, Canada, Mexico, the Caribbean, Guatemala, Panama, Dominican Republic, the Philippines, Guam, Spain, Japan, Cuba, and most recently in Poland.

All the Order's ceremonials and business meetings are restricted to members though all other events are open to the public.

In the 2007 fraternal year the Order gave the US \$144,911,781 directly to charity (1.1 billion in charitable contributions in the last 10 years) and performed over 68,695,768 man hours of voluntary service.
