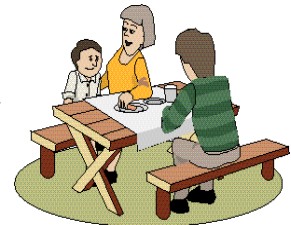
John is another Knight Brother who was not raised a Catholic, but converted.

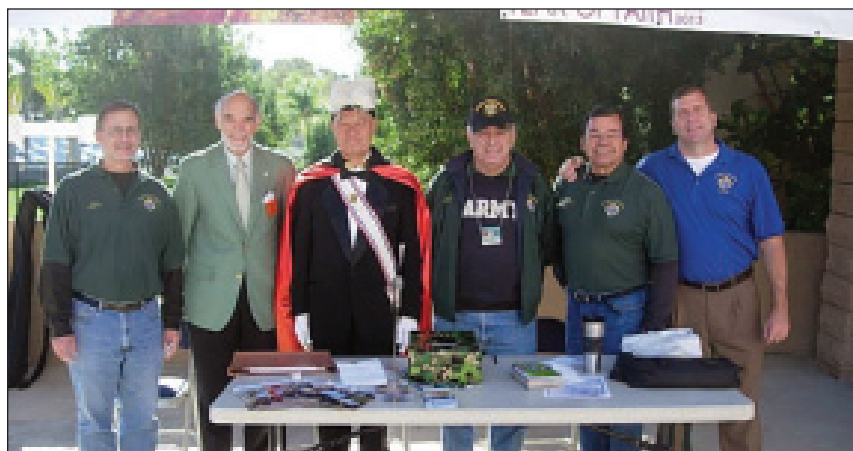

## *Recycling team plans for new area at church*

Father Dave has asked the Knights to vacate the current recycling area behind the Parish kitchen and requested that it be done by the time he leaves. We believe we will be allowed to build a new area in the far end of the lower parking lot.

The recycling team has foreseen the need for more space and substantial planning has already been done over the last several months.

A plot plan has been developed (**Please see next page**) and the necessary work has been identified. Although the specific cost has not been developed, enough work has been done in this area to recommend that the Council approve a budget in the amount of \$15,000.

The ramifications of not approving the project will be cancellation of the weekly Recycle Program which raised \$8,700 in the last 12 months, not including substantial material collected and processed during the Saturday Program.

The total revenue from this program could be as high as \$100,000 annually.

The Council Officers have reviewed this proposal and recommended its approval.

We will hold discussions at the December meeting and plan to hold it for Vote at the January general meeting.

This income is important to the many Charitable gifts given by our Council.

Please attend the December meeting to hear any discussion and certainly plan on being at the Jan.2 meeting to vote on the project.

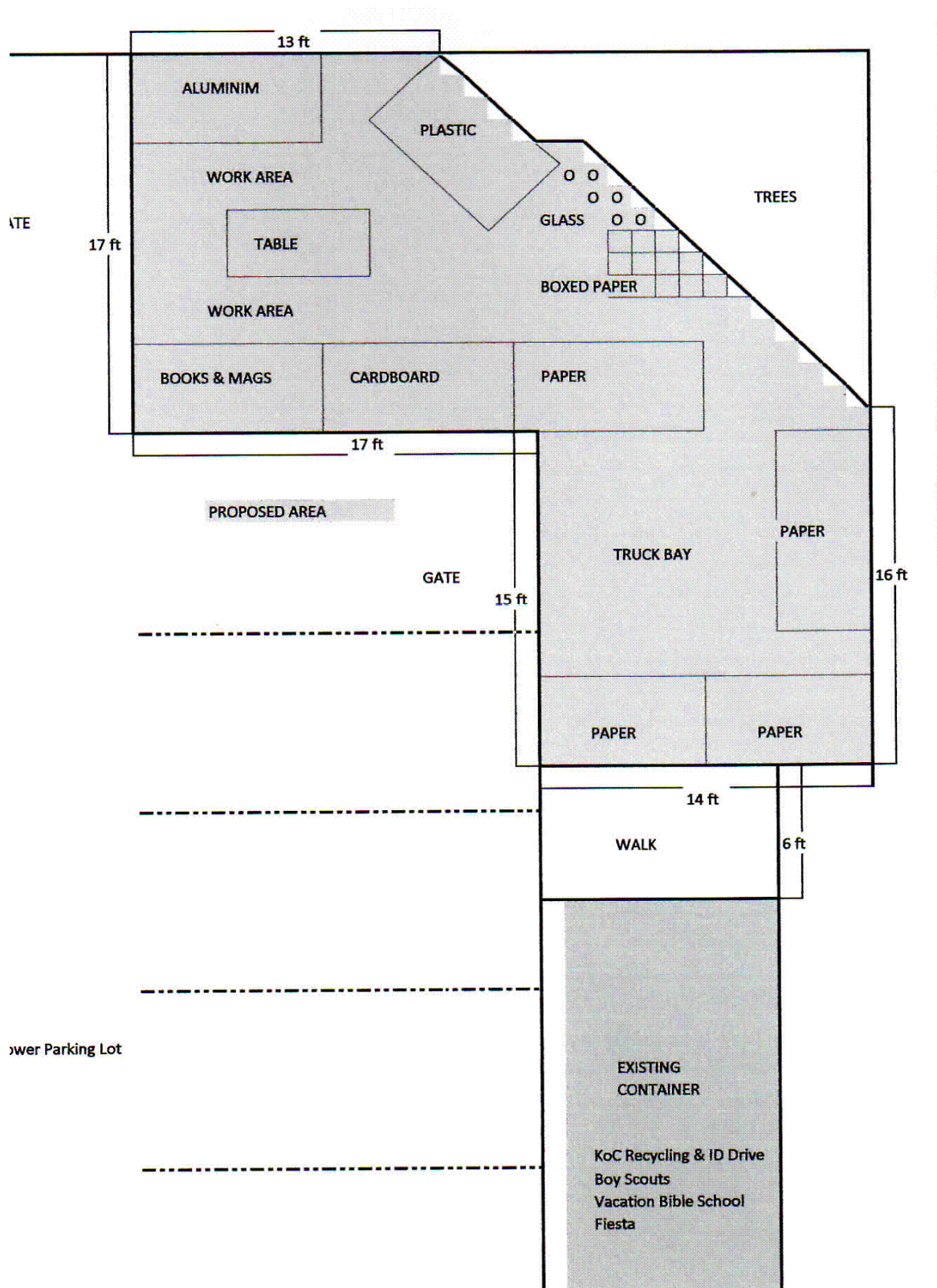


