District Deputy's Message: Fraternal activities are of utmost importance

One of my responsibilities as District Deputy is to encourage all Councils to submit reports to

Supreme. Several were recently due and I want to thank all those involved in preparing the fraternal activities, semi-annual audit, basket free throw contest, and Special Olympic reports.

Let's examine one, fraternal activities, where we report our charitable work for the past year. With all the talk about reducing or eliminating tax breaks for charitable organizations, documenting our good work is especially important.

We need to broadcast to our parish, community, and government exactly what we do.

The 2012 results have not yet been compiled, but during 2011, KofC donated \$154,651,853 to many worthwhile causes and of that amount, \$29,183,386, came from Supreme Council.

Their funds come primarily from insurance sales. One of our partners is Special Olympics to which Supreme Council gave \$250,000 and \$3,378,000 was donated by local Councils, assemblies, and circles. Supreme just cut a check for \$400,000 to the Military Diocese to fund scholarships for men training to become priests.

There is a critical shortfall of priests who serve our men in women in the Armed Forces. A complete list of Supreme Council's contributions will appear in an upcoming issue of Columbia magazine.

Volunteer man-hours grew to 70,053,149 and the number of

Added funds are needed for recycling area

We are requesting from the Council an additional \$7500 allocation to complete the original request to fund the construction of the new recycling area.

The riginal estimate of \$15,000 was based upon partial data that did not meet all the specifications set forth in the final drawings and meeting with John Blaney, Construction Supervisor.

John did a preliminary study of the plan and the defined more precisely the specific needs and requirements that must be met.

We have three bids submitted, \$19,750, \$27,709, and \$22,200. A Brother Knight resubmitted his bid, \$14,000, and it was accepted at the last officers meeting.

A final contract will need to be drawn up and all items in the bid clarified and accepted.

We also have the original cost of the plans and the \$1,000 that needs to be paid to the city of Lake Forest.

A committee of John Blaney, George Nothhelfer, and Bob Morgan has been formed to supervise the project.

The additional amount is to cover the costs over the initial \$15,000 and to cover any contingencies that may come up.

We are close to the final goal and we do not want to hold anything up.

It is the committees' intent to complete this project for the least expense to the Council, in the most efficient manner that is possible.

Your officers will also have oversight on the monies spent. We do not expect to use the total amount of \$22,500 but we need

This will take place on Friday, April 19 at the State Deputy Testimonial Dinner at Fr. Kass Council in Buena Park.

This matter will be brought up for discussion at our March 6 business meeting and a motion for a vote will be requested at our April 3 meeting.
