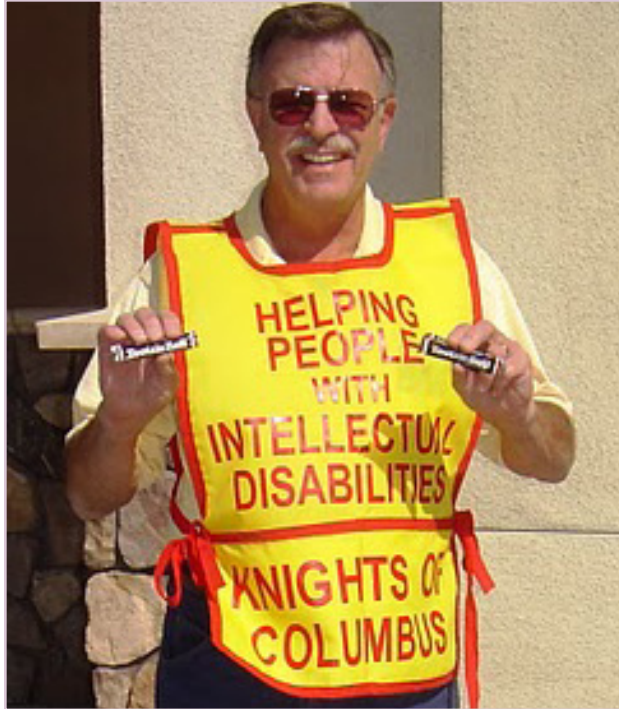

## **Family of the Month**

### **Chuck and Sylvia Agozino**

It is my great pleasure to introduce Chuck and Sylvia and why they are our chosen family of the month.

In 1966, at the age of 23, Chuck was already a Third Degree member of the KOFC at St John, the Evangelist Parish in Inglewood, Calif. He recalls being motivated to become a Knight in response to his admiration for the way his co-worker and mentor, Tony DiTomasso, was living his life as a faithful Catholic family man and long-time Knight of Columbus.

Inactive for many years, Chuck sought reinstatement in 2000 to join his KOFC friends he had been grouping with at St. Cecilia's in Tustin. He transferred to Bishop Johnson Council in 2005 after moving from Irvine to Lake Forest and to Santiago de Compostela Parish.

For the past several months, Chuck has been a steadfast volunteer on the Monday/Tuesday mobile home park recycle and paper collection team, a big part of our enviable recycling program. Something he got into by accident, so to speak.

It started last year at a Forest Gardens dinner when tablemate Bob Morgan mentioned he needed a substitute for the following Monday recycling pickup. Chuck said he'd do it, thinking it would be a one time deal, but he liked it and the rest is history.

### Protocol For Exemplifications

Candidates and observers will dress in a manner fitting the dignity of Formal Knights of Columbus Ceremonials. Collared shirts, dress slacks, socks and shoes are the minimum standard. Shorts, tee shirts, sandals, jeans and similarly casual attire are inappropriate. A jacket and tie are the desired standard for Third Degree Exemplifications.


First degree candidates should arrive with a Council Representative, preferably the Financial Secretary, who has his signed form 100 which has been read and approved by the Candidate's Council. The representative will provide the candidate's Rosary, Membership Card, and copy of "These Men We Call Knights" to Host Council. He will also certify that the Candidate has signed the gaining Council's Constitutional Role prior to arriving at Exemplification. Notify the Chapter Ceremonials Chairman in case of change.



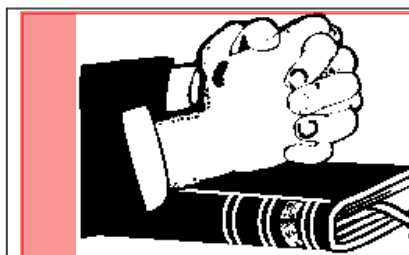
