hope to continue the work John accomplished and build on the success of our council in the coming year.



Bill and Sue Stegall


Over the years, these most deserving Family of the Month honorees Bill and Sue, have participated in the Santiago parish life in many ways.


Gene Ganley Recycling Report

For June, our successful program raised \$2,380, one of the top one-month totals of the year. It raised our total earnings to \$386,792. We continue to work hard together to increase our earnings. We applaud all those that contribute to these efforts but need to see more of the new Knights. We look forward to seeing all of you Saturday, Aug. 8.

Our program is successful because those of you that take time to support it and make the sacrifice and we greatly appreciate it. I wholeheartedly thank all my Brothers for the great job in stepping up on Saturday.



We need more Knights to participate since the youngsters will not be coming this summer. We also need the Knights to be aware of the sorting process. If products get mixed together, it costs us a lot of money. Please ask one of us if you have any questions on sorting.

We are now back of our old method of recycling, which is much easier. We continue to pursue our curbside certification and are making progress. We were recently sorting and weighing the recyclables from the mobile home parks before any of other materials are processed. That weight needs to be recorded for state purposes.

Bob Morgan and I will be meeting with the City of Lake Forest, Director of Public Works and the Management Analysis reps to discuss the letter of acknowledgement required by the state from the

city. More on that later.

A special thanks to our Monday and Tuesday morning crew for the dedication and extra hours they spend in making the program a success.

These guys are there more than just Mondays and Tuesdays to keep up with other recycle projects that make our program go.

You have no idea what additional time and effort is spent by these people until you come and investigate. We generate 40 percent or more of our program from this group. We need more retirees to help for a couple of hours on Mondays and Tuesdays. Everyone has a good time.


Family Matters:

Insurance Report

Illness can be a factor that impacts work

While jobs may be safer in 2014, accidents, injuries, and illnesses that can impact the ability to work still happen.

Most, in fact, do not happen on the jobsite or place of employment. Did you know that a 2011 study revealed that more than 95 percent of the long-term disability claims on file were not work related?

The Knights have always sought to protect members' families from the "loss" of a breadwinner. I'm sure you know all about Father McGivney's vision for our first insurance program.



But you may not know that he also wanted to find a way to help members who couldn't work because of an illness. After all, the loss of the breadwinner does not have to mean that person's death; it can also mean the loss of the breadwinner's income.

Consider that loss for a moment. How would your family fare if a source of income suddenly stopped?

Could a dual-income family manage on one income stream? What about young families with a working father and a mother who cares for the children? What if his income halted due to an accident or illness?

I've heard some people say


