Council wins three awards at KofC state convention

The 2016 California Knights of Columbus State Convention was held in Santa Clara May 20-21. In attendance from Bishop William R. Johnson Council 9487 was Grand Knight Michael Klett, Past Grand Knight John Blaney, and Deputy Grand Knight Roger Sonnenfeld. At the convention Brother Steve Bolton was elected State Warden. Council 9487 won three awards.

The first award was for the highest dollar amount raised without a parish drive, \$15,974, to support the humanitarian mission of the American Wheelchair Mission 2015-2016.

The second was for the annual Fund Raising Drive for the Columbian Foundation Supporting People with Intellectual Disabilities. Our Council finished in first place for raising \$37,30, more than twice the amount that the second place Council raised.

The third award was a banner ribbon for participating in the Columbian Charities with our "365"

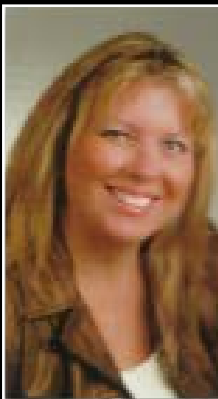
