We accomplish in our lifetime only a tiny fraction of the magnificent enterprise that is God's work. Nothing we do is complete, which is a way of say-

ing that the Kingdom always lies beyond us. No statement says all that could be said. No prayer fully expresses our faith. No confession brings perfection. No pastoral visit brings wholeness. No program accomplishes the Church's mission. No set of goals and objectives covers everything.

This is what we are about. We plant the seed that one day will grow. We water seeds already planted, knowing that they hold future promise.

We lay foundations that will need further development. We provide yeast that produces far beyond our capabilities.

We cannot do everything, and there is a sense

Terry appeared on EWTN Radio from 2007-2016 and currently hosts The Terry and Jesse Show weekdays on Immaculate Heart Radio.

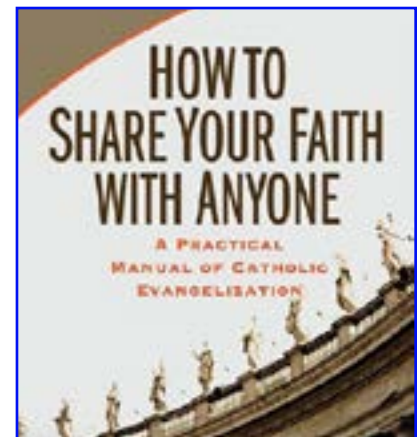
His most recent book, “How to Share Your Faith with Anyone” published by Ignatius Press, garnered a Catholic Press Association Award for Evangelization.

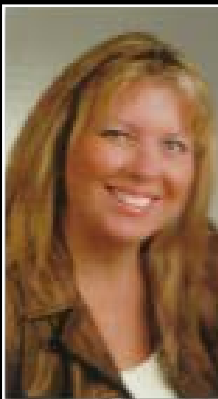
