By the time you receive this we will most likely have completed participation in the Parish Festival. Council 9487 was well represented on October 1, at the Diocese sponsored Walk For Life. More than a thousand Knights, family members and Catholics from all over Orange County spent Mass together followed by a statement march. The request that was presented was all voters should vote NO on Proposition 1 which would add the right to abortion to the California State constitution.

As most of the commercial sites no longer are allowing us to use their facilities for the "Tootsie Roll Drive" we will be running our program with direct mail solicitations to Knights Families, and hold patio collections after the first of the year. - Meeting opened with prayers and Black Box announcement. Donations to St. Vincent De Paul Society.
- September minutes approved unamended.
- Parish October Festival announced along with sign-up sheets for volunteering.
- Report of the Walk for Life at the Christ Cathedral given. Bishop of Orange County has approved the Walk for the next five years.
 - 1100 people at the Vietnamese Mass, and about 3000 attended the Walk around the Cathedral.
- Volunteers for Adoration on the first Friday of the month requested
- Treasurer's report, Bro. Stewart: Checking account \$34,181.29. Increased due to money transfer from the Vanguard account to cover Golf Tournament expenses. Vanguard account has \$45,337.
- No membership updates from Br. Ricardo.
- Br. Vince Vasquez thanks the Exemplification Team for assisting at Holy Trinity in Ladera Ranch.
- Recycling report: \$1700 for the month. As always, help is needed Monday mornings.
- DGK Dave Adkins reports:
 - provides a brief overview of the Golf Tournament. Increased costs cut into net income, but overall still a success.
 - More details provided on the Parish Festival requirements – volunteers and food/drink donations.
 - Past Grand Knight's dinner Sunday, November 13. \$35 per person.
- Call out for Fourth Degree Knight's to partake in the Garden of Innocence. Br. Mike Sofka explains the Garden of Innocence—remembrance for abandoned children who died right after birth.
- Donut Sunday for October 9th announced, Knights' volunteers needed.
- Br. Benny goes through the Hospitality needs for the month's special masses.
 - Notables: November 1st 6AM, 8AM, & 6PM masses.
 - No 6am mass on Thanksgiving Day (Nov 24). Only 8AM.
 - New times for Christmas Eve (4PM, 6PM, 10PM). Christmas Day 8:30AM, 10:15AM, 12:00 noon in English. 1:45 Spanish, no 6PM.

OCTOBER 5 BUSINESS MEETING MINUTES Cont'd

- Insurance Agent Mark Yubeta report.
 - KofC reaffirmed with highest financial strength ratings. First place according to Standard & Poors amongst all Insurance Companies.
 - Expanded Product offerings for 401K's and IRA's. Highlight's the Catholic Difference. USCCB approved investments.
 - Rates of return are equal or better than comparable market offerings.
 - Member's may get call from Mark Yubeta's assistant—keep that in mind.
 - Fraternal Benefits Seminar coming up for Catholic Charities.
- WGK John Teeter asks for members to consider chairing the ID (Intellectually Disabled) Drive.
 - Discussion ensues about sending out letters asking for donations and setting up a collection table after mass. Compared with old method of soliciting donations at public businesses (grocers etc) and pros/cons/success/failures.
 - Br. Pat W mentioned that Br. Phil B had a list of corporate donors that should be useful
- Other Fundraising Option – Poinsettia sales to the Parish. Other councils have generated significant income from this (as much as \$10,000).
 - Logistics need to be worked out but council sentiment is that the idea is viable.
 - Reserving the Parish Kitchen requires 6-month lead time, making fundraising dinner's a challenge.
 - Br. Michael Klett ordered Keep Christ in Christmas magnets. Order via the KofC9487 website.
- Sick and Distressed List Prayers offered.
- Bottom line expenses and income reported. Revenue \$24,824.38 (includes \$15,000 from Vanguard transfer). Expenses \$20,814.04.
- Br. Don B accepts the Knight of the Month on behalf of Br. Rich Ingrassia. Br. Rich honored for his great work as Treasurer.
- Lady France and Br. Stewart Imagawa honored as Family of the Month.
- District Deputy Dan Hoffman arrives and provides a positive update on KofC9487's progress toward Star Council. Almost halfway on meeting our growth goals set by Supreme.
 - Icon of the Holy Family traveling the country, will be available to Parishes by request of their KofC council.
- Closing Prayers.



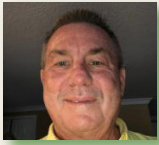


