A NICE RESOURCE HAS BEEN OBTAINED BY OUR COUNCIL

Brothers, in 1911 Ray Harroun won the first ever Indianapolis 500 automobile race. Some feel he had an unfair advantage. It was not that his car had a more powerful engine, better brakes or handled better than the other cars. The advantage he had over the other cars and drivers in the race was that he had installed a rear view mirror on his car. Most auto historians feel this was the first time a race car was equipped with a rear view mirror. Ray Harroun was able to see the other cars behind him and this helped him stay ahead of the other drivers.



Philosophers have always contended that we must know and understand our past in order to progress forward without repeating

the mistakes of the past. They also contend that knowing one's past helps one understand the present.

So where I am going with these thoughts about knowing what is behind us? Great question, and I am glad that you asked it! Our council has obtained a very interesting history book titled History Of The Knights Of Columbus in California Vol II 1972 -2002.

The book has 8 sections that cover activities of the California Knights of Columbus between 1972 and 2002. Specifically 1.State Convention Histories 2.Biographical Sketches of State Deputies. 3.The Hierarchy of California. 4 Chapters in California. 5. The Fourth Degree in California. 6. The Councils of California formed prior to 1971. 7.The New Councils of California formed after 1971. 8. Corporations.

Some information that I found interesting in this book include what social issues The California councils tackled at each state convention, the founding officers of our council 9487 and the founding of the Orange County Chapter of The Knights of Columbus.

The book will be kept with our council materials so that any brother may examine and read the book. It is an excellent snapshot of the California KoC from 1972 to 2002. I

urge everyone to spend some time reading about our history.





I WOULD LIKE TO SHARE MY EXPERIENCE WITH A VEHICLE DONATION

Brothers I am fortunate to have a very nice neighbor who is a 97 year old widow. About 2 years ago she surrendered her driver's license. Her car, which she bought new in 1993, and had a very strong emotional attachment to it, has been sitting in her garage unused since that time.

A common occurrence with cars that do not get driven is their seals shrink and dry out thus causing fluids to leak out. This was the case with my neighbor's car. She told my wife that it was time to sell her car but she did not want to deal with strangers coming to her house and also answering mechanical ques-

tions about the car that she did not have the knowledge to answer. My wife said to let Mark sell the car for her and so they decided that I would take care of selling the car. After almost 40 years of marriage I am used to being "voluntold" by my wife.

The situation was, to get the car repaired would cost close to what the car was worth, and to sell a car with mechanical issues can be difficult. I gave the situation some thought and got an idea. I asked my neighbor what she thought about donating the car to a charity. It could be donated in "as is" condition and would probably be the best way to get rid of the car. She liked the idea and told me whatever charity I chose would be fine with her.

I did some research and decided to investigate donating the car to the Catholic radio organization Relevant Radio. They have a link on their website where you provide some information about the car such as vin#, title status, registration status and the car's condition and everything is set up through the website. My situation, however, was that I was not the owner of the car but rather an agent of the owner so I called Relevant Radio's donation number to discuss the circumstances.



It was a very smooth and easy process. I would be the contact person and provide the car information (vin#, title info, mileage, location and condition of the car). All vehicles are accepted, running or not. Once I gave them this information I was told a towing company would be in contact with me within 5 business days to arrange to pick up the car. 2 days later the towing company called me, asked several questions such as does the car run, are the tires inflated, the title number, the name on the title and the location of the car. They explained that the driver would leave a pick up receipt, a form with the release of liability information on it, and would need a signed title when they picked up the car. They would also complete a DMV 262 form with the car owner allowing for the change of title. We agreed on a 4 hour window for the car to be picked up and were told that the driver would call me 30 minutes prior to his arrival. This is exactly

what happened. The cars are sold at an auction and the funds are given to the charity. The charity then mails a final receipt to the former owner with the sales price of the vehicle on it. A minimum sales price of \$500.00 is guaranteed by the charity.

This whole process went very smoothly and I wanted to share my experience in case a brother is in a situation to donate a vehicle but unsure of the process. In my case this was a true win - win process for everyone involved.
